PRINCETON ATTORNEY HANAN M. ISAACS AWARDED CERTIFIED MATRIMONIAL SPECIALIST DESIGNATION BY THE NJ SUPREME COURT

Princeton, NJ (April 21, 2009) – Princeton attorney Hanan M. Isaacs has been designated a Certified Matrimonial Specialist by the New Jersey State Supreme Court. This is a rare designation with only a small percentage of the 70,000-member New Jersey Bar achieving that designation. The Supreme Court awards the Certification only after a thorough review of a detailed application, practice credentials, positive judicial and peer recommendations, completion of significant continuing education, and extensive written testing.

According to the Board on Attorney Certification, the Supreme Court's establishment of the certified specialist designation was to help consumers find attorneys who have a high level of competence in particular fields of law.

Matrimonial law covers prenuptial agreements, and domestic partnerships, divorce litigation, divorce settlements, annulments, alimony, child support, separate maintenance, child custody, child relocation cases, equitable division of jointly acquired assets and debts, Prevention of Domestic Violence cases, juvenile delinquency cases, name changes, and all similar matters arising out of family-type relationships.

The Board explains that attorneys may be designated by the Supreme Court as "certified attorneys" only after they demonstrate superior experience, education, knowledge, and skill in a specified area of law practice; pass a rigorous examination; and are recognized

by their legal peers as possessing advanced skills and a reputation for excellence in the designated specialty.

Hanan Isaacs said, “I am honored to be one of only 137 certified Matrimonial Specialists statewide, which reflects my 28 years of demonstrated experience, dedication, skill, and credibility in the vitally important field of domestic relations and divorce.”

In addition to his work in the matrimonial field, Mr. Isaacs has recently been chosen by his peers for the fourth year in a row for inclusion in *The Best Lawyers in America*® in the field of Alternative Dispute Resolution.
